We also set some general goals for the semester at retreat, such as connecting with students in each college for feedback, promoting campus-wide mental health, sharing resources to students, recruiting members for next year, and continuing with State System advocacy.

We are looking forward to the Chancellor's visit to campus, where our Executive Board will be attending the student leadership roundtable with him and encouraging the rest of the board to attend the open forum directly after; we are continuing PASSHE Advocacy efforts in other ways with handwritten letters to legislators, a social media plan to share student stories, a potential meeting with one of our senators, and a photo postcard thanking stakeholders for their support of KU and the State System. We're also encouraging other students to get involved with advocacy efforts as many of you might've seen in the campus announcements yesterday.

Some recent highlights of SGB events ~ bingo & brunch (~70 students attended), involvement fair, Kindness Karnival, Connecting with COB, LAS Meet the Reps, Study & Chill with LAS and Academic Affairs, – successful, good turnouts, great to connect with students early in the semester. There's also an SGB info session today at 11am that will likely be just as successful for those interested in running for our upcoming elections.

Besides that, we had a few larger accomplishments from our committees: B&F passed the preliminary budget; KUSSI approved; waiting for final B&F and general board approval; onto special funding

C&P did re-distribution.. We lost 2 seats due to enrollment being down but we are still looking at strong rep numbers; working on a resignation & dismissal policy; still helping other orgs with their status changes/constitutions to support campus involvement as a whole
